

NOTICE OF PUBLIC HEARING

Advertising Bylaw

Pursuant to the *Municipal Government Act*, R.S.A. 2000, c. M-26, as amended, Section 606, the Council of the Summer Village of Itaska Beach hereby gives notice of its intention to adopt:

Bylaw No. 2025-03 Summer Village of Itaska Beach Advertising Bylaw

The Council of the Summer Village of Itaska Beach is proposing to adopt a new Advertising Bylaw. This will be a new bylaw and does not replace any existing bylaws.

The **Advertising Bylaw** contains advertising methods that are likely to bring matters advertised by that method to the attention of substantially all residents in the area to which the bylaw, resolution or other thing relates or in which the meeting or hearing is to be held.

The main method of advertising is intended to be publishing notices on the Summer Village website, and copies of those notices may be emailed to those residences who have provided their Email address to the Municipality, and by mail to those that whom the Municipality does not have an Email address for. This would eliminate the need to advertise the notice in a newspaper for two consecutive weeks and enable electronic advertising instead of direct mail-outs to all residences.
